

No bearing trees of record were located.

The location of this corner is in the middle of a large Marsh.

Dechant provided me with survey notes from his work in 1994. From these notes I was able to determine the location of the iron pipe.

I found a 2" capped iron pipe leaning a bit to the North, it stands approximately 4 feet above ground. There is a K stamped in the top. Measurements were taken where the pipe enters the ground.

I accepted this monument as the best available evidence of the original government corner.

Describe or show any material discrepancy between the location of the restored corner and that of the corner previously restored or re—established.


George Cole established this corner in November 1851.

- S L Kennedy was at this corner, in the late 1930's, during a survey for the Wisconsin Conservation Commission. There is no record of this survey, but is mentioned on several tie sheets and a survey by Bergman. Kennedy set several monuments in the area, all of which were capped iron pipes with a letter 'K' in the cap.
- O O Bergman was at this corner, in July 1954, during a survey in several sections in this area. He shows an existing pipe at this corner.

Gary Dechant was at this corner, in April 1994, during a survey in Section 29. He shows on a tie sheet for the SE Corner of this section that he found a capped 2" iron pipe set by Kennedy at this corner.
