Justice Center/Courthouse/Jail:

- The well shut down parts have been ordered.
- Magnetic hold on doors in the Justice Center will now release during a fire alarm.
- -We had flooding on 1st floor. The basement pump put out more water than the sewer line would handle. We need to test further to see if we have a plugged line or an engineering issue.
- -We had 2 handicap operators installed at the Human Service entrance. We are waiting to get the power ran so that we can start using them.

Rolling Hills:

-We did have generator failure this month. I was able to bypass the automated controls and it started working normally after that.

206 K Street

- -We are moving forward as fast as possible. We are trying to have the work completed for UW Extension to move mid-January.
- -We have a new entrance door ordered.
- -I thought we would be able to do the plumbing but found out that we needed to contract it out.

Property Manager:

We had one employee retire as of January 2. We are working on filling that position from candidates that were previously interviewed. -We have had a couple people that missed the tax delinquent
