- The meeting was called to order in the Monroe County Board Assembly Room at 1:00 p.m. by Chair Dean Peterson.
- Public Comment Period None.
- Set next meeting date/time Wednesday, July 10, 2019 at 1:00 p.m. in the Monroe County Board Assembly Room.
- Minutes Approval Motion by Rod Sherwood second by Mary Cook to approve the May 8, 2019 minutes. Carried 5-0.
- Surplus Property Disposal/Auction/Sales Garry Spohn explained the need to get rid of excess surplus property. Discussion. Motion by Douglas Path second by Rod Sherwood to approve a county surplus auction. Carried 5-0.
- Properties Offered for Purchase Garry Spohn explained that Bruce Wanlass is interested in sitting down and discussing the potential of selling his property. Discussion. Motion by Douglas Path second by Rod Sherwood to have Tina Osterberg look at the purchase price of the Wanlass property and the cost to access and create a parking lot in the grassy front of the Justice Center. Carried 5-0.
- Repurpose of Funds Garry Spohn explained 2019 repurpose of funds in the amount of \$1,525.00 for the Extension building wiring that is needed to be brought up to code. Motion by Douglas Path second by Mary Cook to approve budget adjustment. Discussion. Carried 5-0.

  alarm system should be arriving soon; installation of door releases on the magnetic locking doors

## Justice Center/Courthouse/Jail:

- The new board for the Human Services panic buttons will be programmed and installed soon.
- We have had the roofers back several times to fix roof leaks.
- -We are working with NAMI and Masters to fix the problem with the Multistack. They have made some changes and we are waiting to see if the problem is fixed.
- -The ejector pump line has caused some issues on first floor. We may need to change some things on the line.
- -We have been working on a solution for a camera and door service contract. The vendor that installed our present system is no longer in business.

- -We had our state survey. Overall the survey went well on the maintenance side.
