- The meeting was called to order in the Monroe County Board Assembly Room at 1:00 p.m. by Chair Dean Peterson.
- Public Comment Period None.
- Set next meeting date/time Wednesday, December 11, 2019 at 1:00 p.m. in the Monroe County Board Assembly Room.
- Minutes Approval Motion by Mary Cook second by Rod Sherwood to approve the 10/09/19 minutes. Carried 5-0.
- Justice Center Projects Garry Spohn explained that two heaters have been replaced in the
 Justice Center. The committee discussed the remaining funds in the Justice Center budget. The
 committee had asked the County Administrator to reach out to City of Sparta Administrators
 regarding a parking lot share, the city at this time does not see the need for additional parking on
 the cities behalf. An email was provided to members from the historical society regarding the city
 ordinances of the historic district.
- Funds from Solid Waste Auction Garry Spohn explained that Solid Waste is selling a scale shack and a deck. The ordinance requires all funds of surplus property to be returned to the General Fund. The Solid Waste Committee would need to bring a resolution forward to get an exception from the Surplus Property Ordinance.
- Property Insurance on Vacant Buildings Shelley Bohl, County Clerk explained that the vacant community service buildings area currently insured at actual cash value and general liability insurance remains.
- Tax Delinquent Properties Garry Spohn explained that March 10, 2020 is the court date to take judgment for the 2018 foreclosed parcels. Two properties have been remedied.
- The Buildings Manager Report was provided.
- Items for next month's agenda County Surplus Property Ordinance.

Justice Center/Courthouse/Jail:

- -We have ordered 6 more heaters to replace the undersized units in the garage areas.
- -We have modified some areas and added cubicles to prepare for staff changes in Human Services.
- -We are looking at cooling units to add in housing control and master control.
- -We will be having a holiday tree display around the Court and Main Street area.
- -I have been trying to get quotes for sealing the floors in the shop area to stop water from seeping to the basement area. I finally have 1.

Rolling Hills:

- -We will be installing some new piping to connect the plumbing project to the hot water tank. This will save a large sum of money compared to contracting the work.
- -Abatement was completed in a few rooms and new carpet was installed.
- -We had some roof repairs done. Some roofs are nearing the end of their life.
- -We closed in an opening in the bus barn where a door had been. The door had been ripped off during a summer storm.
- -We received a budget number for roof replacement.
- -We will be installing a plumbing line from the hot water heater to D unit.

202 South K Street:

- I am still working with the roofing company to resolve some issues. They will be proposing the solution.

-Village of Kendall has decided that they would like to purchase one of our tax delinquent properties.
