- The meeting was called to order in the Monroe County Board Assembly Room at 1:00 p.m. by Chair Dean Peterson.
- Public Comment Period None.

- Minutes Approval Motion by Mary Cook second by Pete Peterson to approve the October 10, 2018 minutes. Carried 5-0.
- Relocation of Departments Housed in Annex B / Building D Garry Spohn explained that we are waiting on a certified survey map for the Badger Housing Associates property to house Planning & Zoning, GIS and Forestry Departments.
- Courthouse Project Garry Spohn explained that the final move in date for Human Services is November 28th, 2018.
- Justice Center Garry Spohn explained that he is looking at transferring remaining Justice
  Center Project funds into 2019. Maintenance has spent a large amount of time on the
  Courthouse remodel, therefore justice center projects were not completed. Garry will be working
  with Finance on and adjustment to be approved by the board.
- 206 South K Street- Garry Spohn explained that floor plans are completed. Work is anticipated to begin work in early December.

#### Justice Center/Courthouse/Jail:

- -Moving has been completed. We are still working steady at requests for the building.
- -Siemens installed the relays on the doors. (Release during fire alarm) I have been working on the final wiring. I am hoping to have that done by the time we meet.

### **Rolling Hills:**

- -Rolling Hills ran a mock disaster drill this month. It is a requirement and helps be better prepared in the event it would happen.
- -We continue to get a high volume of maintenance requests. The building is reflecting the need to renovate or be replaced.

#### **Admin Center:**

-We hired Serv Pro to remove some moldy materials and clean others from the basement. High humidity caused this to happen.

#### 206 K Street

-We are just getting started on the remodel. I don't believe the concrete will get poured this fall.

### **Property Manager:**

We are going to delay filling maintenance assistant position. We feel that we can offer a bit more if needed if we wait until February.
