MONROE COUNTY ECONOMIC DEVELOPMENT, COMMERCE & TOURISM COMMITTEE MONTHLY MEETING – 5-9-19 – Sparta City Council Chambers

The meeting was posted in accordance with the open meeting law. Meeting was called to order at 9:00am by Chair Nodji Van Wychen. Rollcall was taken.

Special Guests – T. Fahning & M. Sund informed the Committee on all the economic development work currently happening in Sparta. The new South Pointe Business Park is off to a very good start with new construction of the Sparta Family Dental Center building, the AMS Micromedical building and the start of the new Martin Warehousing facility. Fahning also said the new Brooks Equipment location will be built featuring heavy equipment and very visible to Interstate 90. Fahning said the 2nd phase of infrastructure is almost completed. He said that they have begun to use new avenues for marketing and have placed an ad in the Milwaukee Brewers Yearbook publication. Fahning said that housing issues are a big concern, especially when it comes to single family homes. He said that Sparta is becoming a bit more of a bedroom community for the LaCrosse market which he said that older homes are being bought and upgraded. M. Sund said that 2 TIDs will be closing very soon which included the East Side Business Park and the Century Foods International headquarters site. Fahning said that there are a few small acres available in the East Side Business Park which they hope to sell off before the TID is closed.

Welcome – the Committee welcomed Tina Osterberg as the new County Administrator, and this was her first week on the job.

Next Month's Meeting – Thursday, June 13^{th} – 9:00am – Kendall Community Center. S. Peterson will make the arrangements.

Minutes – Motion by M. Halverson to approve the minutes. Second by D. Peterson. Motion carried.

Financial/Invoices – S. Peterson said there were no invoices to be approved.

Monroe County Economic Development Corporation update – S. Peterson reported that the concept will not be happening. T. Osterberg agreed as there isn't support from Sparta or Tomah at this time and it's too big of a financial task to think that the Villages could financially support. There was talk about the private sector funding it, but the committee felt that it would a big uphill task to have that happen. The Committee urged the County to look at continuing to fund the. E.D. Coordinator's position even if the corporation idea was not an option currently.

EDCT Committee 2020 Plans – no special plans at this point. S. Peterson suggested that the Committee needs to work closer with any community in the County on their marketing efforts and see if there are opportunities to partner on marketing investments.

County Parks Brochure - no report.

Campground Brochure – S. Peterson said that in the late 90's a brochure was printed, and he was told by J. Hendricks that they had run out of the brochure at the Sparta Chamber. Peterson said the Committee should consider a reprint with updated information since camping is so popular. It will be discussed further at next month's meeting.

GO MONROE COUNTY Activities Guide – the Committee felt a new RFP was needed to be created along with the guidelines of how it should be distributed. S. Peterson and T. Osterberg were going to look in the past minutes/files for a copy of the past RFP and have it discussed at the next meeting.

County Administrator's Report - T. Osterberg reported that it was her 4^{th} day on the job and she was working on the transition from CFO to Administrator. Osterberg suggested that S. Peterson present to the County Board in July about all he's been working on and plant the seed to get the Board to look at funding this position next year and in the future.

IN THE WORKS

Community Venture Network – Twin Cities – Met one-on-one with 12 prospects on 4/12 that have been vetted and are looking at starting, expanding or relocating their business. Up to 6 of them are doing follow-ups with me over the next few weeks.

GROW TOMAH digital campaign — working with the City of Tomah, Tomah Chamber, Forward Tomah, owners of business park land, realtors and commercial property owners on a joint digital campaign to market the City of Tomah. With the success with Sparta's South Pointe Business Park as a state-certified site, I feel that Tomah needs to build a stronger presence with their marketing efforts, especially digitally. This campaign will hopefully be launched by the end of May or early June.

Cashton Day Care – Cashton – open house was held the first weekend in May and are ready to open their doors.

Gen 3 building – Tomah –Murray's on Main is doing well and the rest of the building project will be completed soon, including apartments, professional offices and retail on the main floor.

South Pointe Business Park – Sparta – Dental clinic building is close to completion. The AMS Micromedical building is on schedule and taking shape. A new Martin Warehousing building has been started and they expect to move into that facility by July.

Tomah Healthcare campus – hospital & clinic construction is progressing very well, and the time frames of opening are still on track. We are seeing more interest peaking with the land across the street from these developments.

Connect Community – The premise for this program this year is to work closely with Norwalk, Wilton & Kendall pertaining to the repairing and fully opening of the Elroy-Sparta Bike Trail.

IN THE WORKS

WI Assembly Rural Development Committee Hearing – was 1 of 3 people invited to testify at the hearing in the Capitol in Madison on workforce housing issues in the State of Wisconsin. I was part of the WEDA group that spoke with the State Representatives during their 3-hour hearing. The other Counties represented were Sauk & Barron Counties.

North Dakota Visit – took a contingent from Kendall to North Dakota for 2 days of meetings with the Bio-Sunn company reps and others associated with the Industrial Hemp projects. This was the next phase of finalizing the project in Kendall.

Community Venture Network — Site meetings with 2 prospects in late June and early July. Both are scheduling 2 days of meetings and site tours of areas around the County.

Dollar General – working with a potential site in Kendall. Involves possibly working out an agreement with the DNR on some of the right of way land adjacent to the bike trail through the community.

Elroy-Sparta Bike Trail – working with the DNR on getting the trail repaired and open yet this season. Currently closed from Norwalk to Elroy. The Kendall Depot, the official headquarters of the trail has been closed for 2 years now and am working with forming an agreement between the DNR and the Village of Kendall and have the Village run the Depot during the bike trail season. This closure is having a significant negative impact on the businesses along the trail. They have been without the trail now since late August 2019 and I'm afraid some may not stay in business if they don't get the trail open soon.

GROW TOMAH digital campaign – Digital web site & mapping is 3/4s done. Anticipated launch of site is late June. Working with Wisconsin Badgers on a marketing campaign involving their programs for the football & basketball seasons.

Gen 3 building – Tomah – the housing & professional offices are now open. Great addition to Tomah & the County.

South Pointe Business Park – Sparta – Dental clinic building is close to completion. The AMS Micromedical building is on schedule and taking shape. A new Martin Warehousing building has been started and they expect to move into that facility by July. Working with 2 other prospects that are looking at potential expansions in Wisconsin, specifically at South Pointe.

Tomah Associates land – the parcel of land across from the hospital & clinic construction projects is showing activity. Working with some development companies who may join in the developing of that area.

Connect Community – The premise for this program this year is to work closely with Norwalk, Wilton & Kendall pertaining to the repairing and fully opening of the Elroy-Sparta Bike Trail.
