WHEREAS, the Monroe County Redistricting Committee has met on August 16 and August 20. Census figures were received on August 16; and

WHEREAS, the Monroe County Redistricting Committee has made and recommends the adoption of a plan which would have 16 Supervisory Districts in Monroe County; and

WHEREAS, the recommended plan is made in part hereof; and

WHEREAS, the Redistricting Committee has provided Monroe County Municipalities with a copy of the plan; and

WHEREAS, a public hearing is set for September 1, 2021, to take input from citizens, cities, villages and towns of Monroe County.

NOW, THEREFORE, BE IT RESOLVED, by the Monroe County Board of Supervisors that the recommended tentative plan offered by the Redistricting Committee consisting of 16 Supervisory Districts, be adopted.

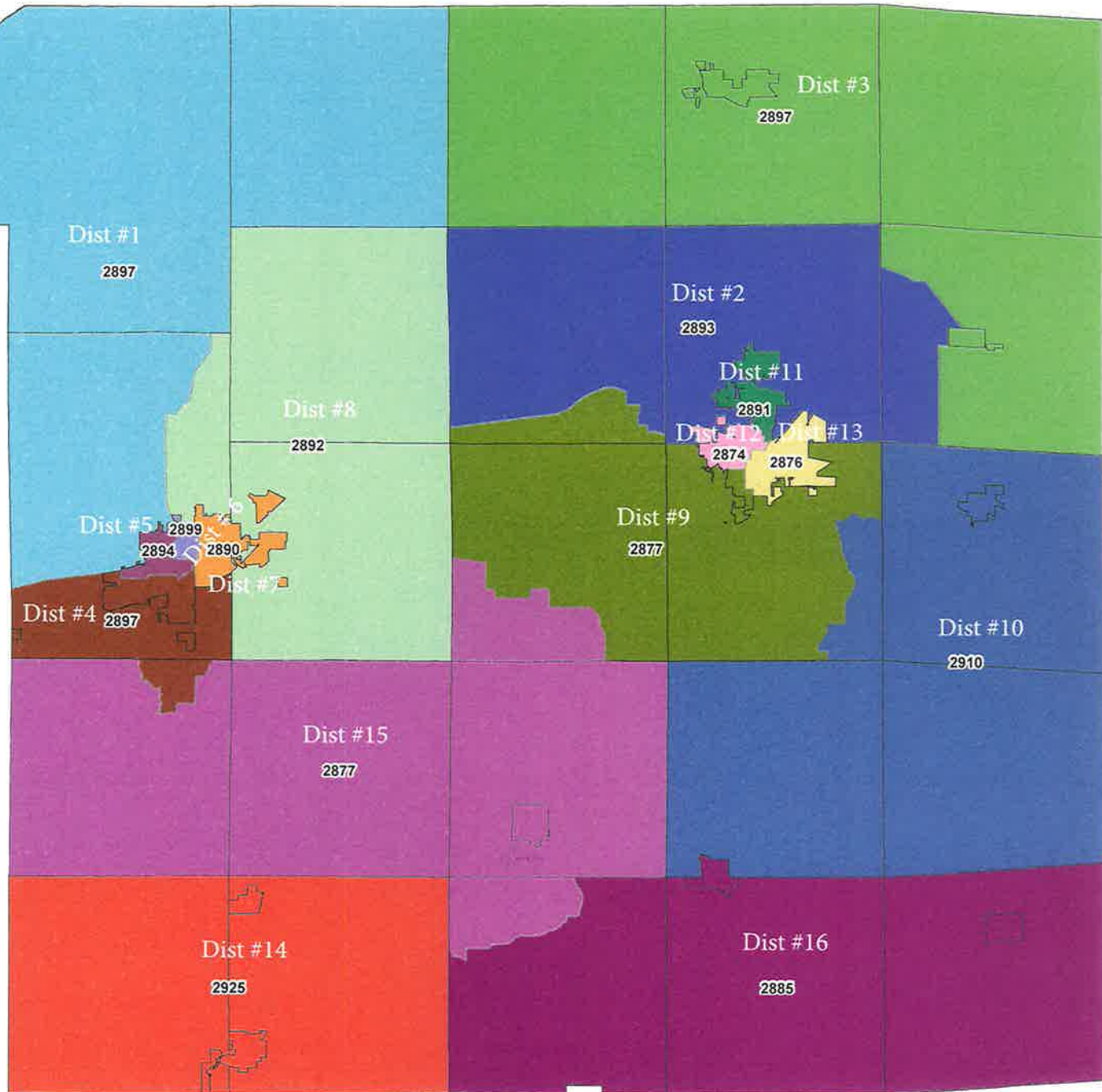
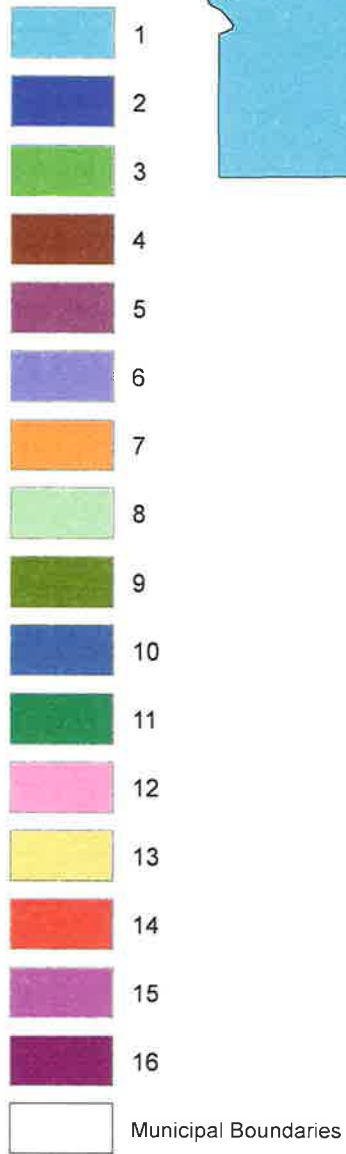
