Notice is hereby given that the Town of Grant, Monroe County, Wisconsin held an Open House Dec 14, 2021, 4-6 pm at the town hall located at 3975 Cty Hwy E, on Resolution 2-2021, Abandon Arizona Rd, located within the town. On September 28, 2021, the sole landowner did execute and file with the town clerk of the Town of Grant, Monroe County, WI, an application to have Arizona Rd, a town road, abandon. This request was posted 30 days in advance and published 30 days in advance, three (3) times in the local newspaper. This was properly posted in the agenda for the regular monthly meeting held December 14, 2021.

The described road is now located on land described as follows:

At center of highway 5 chains 16 links north of school house on NE ¼ of SW ¼ of section 2 town 19 range 2 west thence north easterly course at 7degree east of north 42 chains 30 links thence north easterly course at 30 degrees east of north 8 chains to place of 'termination' at center of highway running through Rudd 'General' Mill Yard, made this 4th day of May 1878 by Wm Randall the same being an accurate survey thereof caused by us and made the line of said survey is the center of said highway and the town is laid out of the width of 4 rods.



In the matter of a current action to discontinue a town road in the Town of Grant, Monroe County, on September 28, 2021, the sole landowner did execute and file with the town clerk of the town an application to the town board to have Arizona Rd, a town road, discontinued.

The described road is now located on land described as follows:

467858 52R/347 14-19N-02W NE NW

Upon application, of sole landowner, for discontinuing said town road, the undersigned supervisors met on Dec 14, 2021 at 7pm at the Town Hall, being the time and place stated in the notice that was prepared in accordance with s. 82.10(3), Wis. Stats, as required by s. 82.10(4), Wis stats, as demonstrated by affidavits that the notices required in s. 82.10(4), Wis stats, had been properly given and published, we examined the town road, and heard all reasons that were offered for and against the resolution.

It being our opinion that the public good will be promoted, the Town Board of the Town of Grant, Monroe County, by this resolution, adopted by majority of the town board on roll call vote with a quorum present and voting and proper notice having been given, resolve and order that a town road be discontinued as follows:

At center of highway 5 chains 16 links north of school house on NE ¼ of SW ¼ of section 2 town 19 range 2 west thence north easterly course at 7degree east of north 42 chains 30 links thence north easterly course at 30 degrees east of north 8 chains to place of 'termination' at center of highway running through Rudd 'General' Mill Yard, made this 4th day of May 1878 by Wm Randall the same being an accurate survey thereof caused by us and made the line of said survey is the center of said highway and the town is laid out of the width of 4 rods.

A map is attached as "Exhibit A: to describe the road. This map is believed to be true and actual.

The provisions of this resolution and order shall be incorporated into the official town map.

This resolution becomes effective January 1, 2022.
