

**TOWN OF ADRIAN
ALL-TERRAIN VEHICLE AND UTILITY TERRAIN VEHICLE
ROUTE ORDINANCE**

SECTION I – TITLE AND PURPOSE

The title of this ordinance is the Town of Adrian All-Terrain and Utility Terrain Vehicle Route Ordinance. The purpose of this ordinance is to establish all-terrain vehicle and utility vehicle routes in the Town and to regulate the operation of all-terrain vehicles and utility vehicles in the Town.

SECTION II – OPERATION OF ALL-TERRAIN AND UTILITY TERRAIN VEHICLES

Pursuant to s. 23.33(4)(d)4., Wis. Stats., except as otherwise provided in s. 23.33(4), Wis. Stats., no person may operation an all-terrain vehicle and utility terrain vehicle on the roadway portion of any highway in the Town except on roadways that are designated as all-terrain vehicle and utility terrain vehicle routes by this ordinance. Operation of all-terrain vehicles and utility terrain vehicles on a roadway in the Town that is an all-terrain vehicle and utility terrain vehicle route is authorized only for the extreme right side of the roadway except that left turns may be made from any part of the roadway that is safe given prevailing conditions.

**SECTION III – DESIGNATION OF ALL-TERRAIN VEHICLE AND UTILITY
TERRAIN VEHICLE ROUTES**

The following routes are designated all-terrain vehicle and utility terrain vehicle routs in the Town:

**SECTION IV – CONDITIONS APPLICABLE TO ALL-TERRAIN VEHICLE AND
UTILITY TERRAIN VEHICLE ROUTES**

I. Pursuant to s. 23.33(8)(d), Wis. Stats., the following restrictions are placed on the use of the Town all-terrain vehicle and utility terrain vehicle routes designated by this ordinance:

A. Routes shall be marked with uniform all-terrain vehicle and utility terrain vehicle route signs in accordance with s. NR 64.12(7), Wisconsin Administrative Code. No person may do any of the following in regard to signs marking Town all-terrain vehicle and utility terrain vehicle routes:

1. Intentionally remove, damage, deface, move, or obstruct any uniform all-terrain vehicle and utility terrain vehicle route or trail sign or standard or intentionally interfere with the effective operation of any uniform all-terrain vehicle and utility terrain vehicle route or trail sign or standards if the sign or

standard is legally placed by the State, any municipality, or any authorized individual.

2. Possess any uniform all-terrain vehicle and utility terrain vehicle route or trail sign or standard of the type established by the department for the warning, instruction; or information of the public, unless he or she obtained the uniform all-terrain vehicle and utility terrain vehicle route or trail sign or standard in a lawful manner. Possession of a uniform all-terrain vehicle and utility terrain vehicle route or trail sign or standard creates a rebuttable presumption of illegal possession.

B. Operation shall be subject to all provisions of s. 23.33, Wis. Stats., which is adopted as a part of this ordinance by reference, pursuant to s. 23.33(11), Wis. Stats.

C. A copy of this ordinance shall be sent by the Town Clerk to the Department of Natural Resources, the Monroe County Sheriff's Department and any other law enforcement agency serving the Town of Adrian jurisdiction.

D. Restrictions.

1. All all-terrain vehicle and utility terrain vehicle operators shall observe posted roadway speed limits.

2. All all-terrain vehicle and utility terrain vehicle operators shall ride single file.

SECTION V – ATV/UTV AND SNOW REMOVAL

Town adopts by reference all applicable statutory provisions of s. 23.33 relating to the use and operation of all-terrain vehicles and utility terrain vehicles for snow removal.

SECTION VI – ENFORCEMENT

This ordinance may be enforced by any law enforcement officer authorized to enforce the laws of the State of Wisconsin.

SECTION VII – PENALTIES

The penalties under s. 23.33(13)(a), Wis. Stats., are adopted by reference.

SECTION VIII – SEVERABILITY

If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable.

ATV/UTV Operation:

The township of Adrian authorizes the operation of ATV/UTV's on STH 16 from CTH T to Hawthorn Rd. including to cross the bridge over the Unnamed tributary that feeds into Chub Creek under Wis. Stat ss. 23.33(4) (d)3. b. and 23.33(11) (am)3.

A person crossing the bridge on ATV/UTV shall do the following:


- a) Cross the bridge in the most direct manner practicable and at a place where no obstruction prevents a quick and safe crossing.
- b) Stay as far to the right of the roadway or shoulder as practicable.
- c) Stop the vehicle prior to crossing.
- d) Yield the right-of-way to other vehicles, pedestrians, electric scooters, and electric personal assistance mobility devices using the roadway or shoulder.
- e) Exit the highway as quickly and safely as practicable after crossing the bridge.

This is adopted by the Town Board of the Township of Adrian on this 12th day of February 2024.




