ORDINANCE # 2008-2

ALL-TERRAIN VEHICLE ROUTE ORDINANCE

Section I – Authority

Pursuant to s. 23.33(8), WI statutes, and general authority under it's village powers under s. 60.22, WI statutes, the town board of the Town of Jefferson, Monroe County, has the authority to adopt this ordinance.

Section II - Adoption of Ordinance

The town board, by this ordinance, adopted with a quorum and by a roll call vote by a majority of the town board present and voting provides the authority for the town to adopt the following all-terrain vehicles routes for the operation of all-terrain vehicles upon the roadways listed in Section III.

Section III - Routes

The following roads in the Town of Jefferson are open to ATV's:

J. Melody Ave. A. Market Rd. S. Omaha Ave. B. Marshall Rd. K. Neon Rd. to Newcabinet Rd. T. Omega Rd. C. Mascot Ave. L. Newcabinet Rd. M. Nestle Rd. D. Mason Ave. E. Matador Ave. N. Network Rd. F. Matchbox Rd. O. Nevada Rd. G. Mega Rd. P. Neville Rd. O. Newark Ave. H. Meadow Ave. I. Meadowlark Rd. R. Olympic Ave.

Section IV - Conditions

As a condition to use the ATV routes, operators shall abide by all state laws regulating ATV operation including the following:

- A. Operate on the extreme right side of the roadway surface.
- B. Left turns can be made from any part of the roadway surface as long as it's safe.
- C. Must not exceed the route speed limit of 35 MPH.
- D. Routes are open for operation from April 1 November 30.
- E. Obey hours of operation, check locally for restrictions.
 - F. Must slow to 10 MPH when within 150 feet of a dwelling.
 - G. Must slow to 10 MPH when within 100 feet of a pedestrian or someone not on a motorized vehicle. (i.e. Horseback, horse-drawn vehicle, bicycle, etc.)

- H. Operate single file.
 - I. Have head lamps and tail lamps on.

Section V - Disclaimer

The establishment of this ordinance is for the convenience of the ATV public only, and the Town Board of the Town of Jefferson makes no warranty, express or implied, that the aforesaid routes are safe for ATV operation.

Section VI – Effective Date

This ordinance shall take effect from and after its passage and publication.
