

## ORDINANCE No. 08-13-02

Amended 01/13/2021

The Town Board of the Town of Wilton do ordain as follows:

**Section 1:** Ordinance No. 08-13-02 is created:

### All-Terrain Vehicles (ATV)/Utility Terrain Vehicles (UTV)

A. **Definition:** The provisions of this Ordinance shall apply to all terrain vehicles (ATV) and utility terrain vehicles (UTV) as defined in Wisconsin Statutes, Section 23.33.

B. **Statutory Authority:** Routes of travel for all terrain vehicles and utility terrain vehicles are created pursuant to the Town authority authorized by Wisconsin Statute Section 23.33 (8)(b) and (c).

C. **Routes Designated:** No person shall operate an all-terrain vehicle or utility terrain vehicle on any Town highway except upon routes and trails designated and marked by official signs posted by Town official(s). The following roads have approved routes and trails when official sign is posted only. When the sign is down the route and trail has been suspended.

- Interior Road
- Iowa Road
- Junction Avenue
- Juneau Road
- Linden Avenue
- Limestone Avenue
- Lincoln Avenue
- Lithium Road
- Livingston Road
- Locust Avenue
- Logan Road
- London Avenue
- Kettle Road
- Kerry Avenue
- Keystone Road
- Killdeer Avenue
- Kiln Avenue

- Kimball Road
  - King Road
  - Kipper Road
  - Knotgrass Road
- The Town of Wilton designates State Highway 71 from Logan Road to Locust Avenue, which includes the Kickapoo River Bridge, as an ATV/UTV route under Wisconsin Statute Section 23.33(4)(d)3.b. and 23.33(11)(am)3.


- D. **Conditions and Restrictions:** As a condition and restriction for the use of the designated
1. All operators shall observe posted roadway speed limits.
  2. All operators shall ride/drive single file.
  3. All operators shall slow the vehicle to 10 mph or less when operating within one hundred fifty (150') feet of a dwelling.
  4. Operators shall comply with all rules of the road and provisions of Chapter 23 of Wisconsin Statutes.
  5. Markers/Signs to be obeyed. All operators shall obey all route or trail signs, markers or limited erected in accordance with this Section.
  6. Declaring Trails Open/Closed. The Town Board shall have the power to declare the routes and trail either open or closed, or any portion thereof as conditions warrant.

E. **Penalties:** Wisconsin State Statute Section 23.33(13) (a) is adopted by reference, as amended.


**Section 2:** All Ordinances in conflict with the foregoing are hereby repealed.


**Section 3:** This Ordinance shall take effect of passage and publication.
