- The meeting was called to order in the Monroe County Board Assembly Room at 4:00 p.m. by Chair Cedric Schnitzler.
- Public Comment Period None
- Monthly Meeting Date/Time Wednesday, January 12, 2022 at 4:00 p.m. in the Monroe County Board Assembly Room.
- Minutes Approval Motion by Mary Cook second by Mark Halverson to approve the 11/10/2021 minutes. Carried 5-0.
- Brownfield Properties #281023930000, #281002295000, #281001665000 Chair Schnitzler explained that grants have been approved for a study of the properties. The study will be completed onsite. The county will apply for a remediation grant if contamination is found.
- Justice Center Safety Committee Requests Garry Spohn explained Justice Center safety requests but not limited to doorways, hallways, card reader, chamber locks, lockdown. Departments will present individual needs to the committee. These requests are not included in the budget. Discussion.
- ADRC Rooftop Unit ARPA Funds Garry Spohn explained that the furnace is in need of heating elements. Discussion. Motion by Remy Gomez second by Mary Cook to request \$40,000 plus the cost of electric elements not to exceed \$50,000.00 in ARPA funds. Carried 5-0.
- Building Improvement Requests Garry Spohn explained building improvement requests by departments. Simple or daily repairs to be completed and or approved by the Property Manager and/or Administrator. It was a recommendation for any building improvement enhancements to come to the committee for approval.

Justice Center/Courthouse/Jail

- -The Justice Center Safety Committee met. They will be coming to our meeting to discuss some things that they would like done.
- -We temporarily closed the hole in the floor above Per Mar to see what the results would be. It is much warmer.
- -I have been looking to see what it would take to move to interruptible power. This could be a huge savings.
- -The boiler modifications have been made. We still suffer some during the coldest weather because of water temp/coil sizing.
- -I will be including a request for installing locks in certain areas of the judicial department.

Rolling Hills:

-We have been taking care of the snow at the new building. We have had 3 nails in tires and a piece of plywood go into the snow blower.

Executive Building:

- -We put in a wall to cover a large window. The office had previously been used as a drive up window. The amount of glass made it difficult to control the temperature.
- -We also added an electric heater to that space.

Property Manager:

- -We will be discussing our Brownsfield grant application.
- -I am still trying to get a quote on HVAC upgrades at the ADRC building. We are verifying that other parts are available for the unit.
