1. Call to order/Roll call at 12:31 PM
2. **Jim Kuhn made a motion to approve the August 2nd, 2022 Minutes, second by Deb Brandt, all in favor motion carried, 8-0.**
3. Member updates and introduction to new members:
 - a. Rick Folkedahl (IT) no major updates
 - b. Deb Brandt (ROD) recordings are down a bit. Admin Committee passed a resolution to alter the percentage of money that the county gets to keep out of the recording fee. State currently gets 80% and County 20%. The resolution supports it being split evenly and will go to the County Board for consideration.
 - c. Gary Dechant (County Surveyor) Normal year. Similar number of maps to past years. Chris Running signed contract to work on Section Corners and will likely get going on that soon.
 - d. Jim Kuhn (Supervisor District #14), no update.
 - e. Brannick Beatse (RPL) normal times, tax bills are being run and will wrap up soon.
 - f. Trent Ziegler (Realtor) Coulee Real Estate and Property Management, likes our GIS website usability.
 - g. Roxie Anderson (Land Conservation) Flood monitoring systems mostly installed. 24 are running and reporting stream levels on upper reaches of the Kickapoo River and the Little La Crosse River 21 registered with National Weather Service.
 - h. Pat Deethardt (Dispatch/Public Safety), now is one of two lead supervisors in dispatch which is now part of the Sheriff's Office. They applied for a NG911 Grant.
 - i. Jeremiah Erickson (LIO) recently completed Shoreland Zoning Layer, has spent a lot of time working on NG911 data this year and is pivoting to spending more time working on PLSS Coordinates layer refinements and will begin to commence work on PLSS based layers soon updating based on new coordinate data collected. Also looking to expand on our ArcGIS Online footprint. Recently discussed GIS use in the Health Department.
4. No action taken on LiDAR Derivatives.
5. Discussion on Wisconsin Land Information Program (WLIP) 2023 Grant Application. Training Grant of \$1,000 would be used to attend the WLIA Annual Conference. Strategic Initiative Grant of \$70,000, to be used for acquisition of 120 section corner coordinates and for time spent remapping and updating spatial data based on the section corner coordinates acquired in that project and others. Base Budget Grant of \$30,144, will be used to cover software and website annual fees. **Jim Kuhn Motion to proceed with the grant application, Brannick second. All in Favor. Motion carried 8-0.**
6. Quick discussion related to the GPS Coordinate acquisition that will take place in 2023. Gary Dechant will work to check the remaining corners and collect GPS coordinates on the remaining corners in the northern half of the county and some remaining after the completion of the 2022 RFP Project being performed by Chris Running.
7. New/Old business
 - a. Daniel's law is something to keep an eye on and its potential impacts to the land records and related industries.
 - b. GCS/Land Nav will require a move to the cloud and that will likely result in some transition fees
 - c. Future meeting date potentially in April on a Tuesday at 12:30 PM.
