- 3. Updates on CCTF activities
 - <u>Donations & Funding</u>: Bob Micheel Updates on last donation made by Leon Community.
 Roxie comments on Grant Funding/FEMA application is under review and funding opportunities.
 - <u>Weather Monitoring Stations</u>: Roxie Anderson updates stations in field. Working with vendor with some technical issues. Rain gauges working and are reporting data.
 - <u>Voluntary Buyouts</u>: Roxie Anderson updates project. Currently have acquired all 8 properties totaling 18 acres of land that will be returned to open space.
 Properties/locations: (2) Town of Sparta (5) Town of Leon (1) Town of Portland. Three demolitions have been completed with estimate completion of remaining demos by the end of summer.
 - <u>Stream Crossing Inventory/Assessment</u>: Bob Micheel comments on two interns that are completing the inventory. Jefferson, Sheldon, and Portland are completed. Interns will give a presentation next month.
 - <u>WI Green Fire Project</u>- Heather Stricker gave an update on the Monroe County Readiness & Rural Economic Opportunity Assessment:
 - o Phase 1 Explore Define and Initiate Completed
 - Phase 2 Assess Vulnerability Analyze potential Impacts and adaptive capacity to determine the vulnerability of populations and community assets. Plan to have complete by August 31, 2021
 - Phase 3 Define Approach, framework and strategies- Develop strategies and involve community workshops. Aug 4th meeting will kick off outreach activities which will include field demonstrations. Community workshops will be in September- need to identify venue key audience and logistics.
 - Phase 4 Implementation Stage and Re-evaluations Vision is to complete Phases
 1-3 this year and start Phase 4 Implementation next year.
 - <u>Coon Creek Watershed- PL566</u>: Bob Micheel, scoping meeting completed last month.
 Outcome of those meetings was the breached structures should be decommissioned.
 The existing structures that are still functioning will need to be addressed in the near future as they have aged beyond their 50 year life. Looking at watershed management and efforts to create a farmer led group. Comments on West Fork area and Public comment period is still open.
 - Wisconsin Initiative on Climate Change Impacts (WICCI) Bob comments on Ag Working Group, publishing expected later this fall. Will try to implement this with the Green Fire Project.
