### 3. Last Meeting Minutes

# 4. Review Vouchers and Credit Card Charges (Discussion)

Highway Department vouchers and expenditures were reviewed. Month vouchers: \$446,511.38.

# 5. Preliminary FY 2024 Budget Discussion (Discussion)

Commissioner Ohnstad reviewed the proposed 2024 Highway Department Budget line by line.

- Accounts within Munis aren't all being used. Activities and projects are tracked within CHEMS as things are done.
- Office Manager Brooke Adams showed reports from the CHEMS system showing availability of detailed breakdowns of expenditures.
- Proposing to eliminate objects not utilized in Munis and consolidate accounts to make the budget easier to understand.
- When CTH W and CTH I are closed out, the bond funds will be used. At the end of the bond cycle it will be completely expended.
- Small Tools accounts currently have 5 separate places in budget, accounts to be combined.
- Acquisition of Capital Equipment equipment added in from approved Schedule of Equipment approved at last committee meeting.

# 6. Local Bridge Assessments (Discussion & Decision)

- Applications have been received but additional information is needed on some.
- Will have resolution for review at next meeting.

### 7. Commissioners Report (Discussion)

Commissioner Ohnstad provided a report.

- CTH U opened last week Wednesday, 8/9.
- CTH PP Approaches, guardrails and signs remain to be completed. Hoping to be opened by the end of next week (8/25).
- CTH W project is paved, shoulders are down, some remedial work to be done yet (striping, sign install, guardrail). Will need to do a final walk through.
- CTH I Started paying Friday, 8/11. Hoping to be completed within the month.
- CTH F once CTH I is completed, will begin prep work for construction. Construction is scheduled to be done in 2024.
- David Pierce asked about PROTECT Grant that had been applied for. David Ohnstad commented it is a
  new program through Federal Highways for infrastructure resiliency. Application was submitted with a
  watershed based approach. If awarded, funds would be used to evaluate, plan, and come up with
  additional estimates to develop and design projects to help mitigate flows before they get to the culverts
  and bridges.

Next meeting will have Bridge Aid resolutions and final budget proposal.
