RESOLUTION ADOPTING THE 2024 BUDGET AND AUTHORIZING PROPERTY TAX LEVIES

WHEREAS, the County Administrator along with the Finance Committee has conducted numerous budget meetings for the purpose of formulating a 2024 budget; and

WHEREAS, said proposed budget was noticed according to Wisconsin State Statues and a Public Hearing was held at 6:00 p.m. on November 1, 2023; and

WHEREAS, the 2024 budget was proposed by the Monroe County Administrator and has been presented and explained to the Monroe County Board at its annual meeting on November 1, 2023.

NOW, THEREFORE, BE IT RESOLVED that the Monroe County Board of Supervisors hereby adopts the budget of \$90,802,795 for the fiscal year beginning January 1, 2024 setting out the budgeted items as roll up codes; and

- 1. Authorizes a county total tax levy in the amount of \$21,793,467 in support of the adopted budget.
- 2. Directs the Monroe County Clerk to apportion a county purpose (operating & debt) levy of \$21,128,895 upon taxable property.
- 3. Directs the Monroe County Clerk to levy the remaining tax of \$664,572 for special purposes (libraries, bridges and sanitation) to be apportioned upon the relevant municipalities.
