# **HOW DOES THE PROGRAM WORK?**

Only noon meals are available at this time. They are delivered by volunteers or paid drivers Monday through Friday, except on holidays or during severe weather conditions. Frozen weekend meals are available on a case-by-case basis. Meal delivery is usually between 11:00am and 1:00pm depending on where you are on the route (intown or rural).

# **NUTRITION PROGRAM**

 Well balanced nutritious noon meals are available to persons age 60 and over and their spouse of any age, regardless of income. A minimum donation is suggested. Special diets are not accommodated.

# Dining Sites

Senior Dining sites are located in communities throughout the county. The congregate setting provides socialization and an opportunity to participate in education and wellness events. Please call by noon 1 day before to reserve your meal.

#### Home Delivered Meals

Besides a nutritious, hot meal, home delivered meals offer a daily visit and welfare check for the homebound. The nutrition program coordinator ensures dietary needs set by our state governing body are met and provides resources to meet the individual's needs.

# HOW MUCH DOES A HOME DELIVERED MEAL COST?

This program is supported by limited federal, state and local funds, and the contributions made by the individuals who receive the meals. The actual cost of a home-delivered meal service is approximately \$12.00 per meal. The cost includes food transport, food packaging, supplies and labor. A suggested contribution range, starting September 2023, of \$4.00 to \$7.00 per meal is recommended to defray the cost of the meal service. You can pay what you are able to afford. No one over the age of 60 is refused services due to inability to pay.
