Monroe County Assistant District Attorney Sarah Skiles Named Wisconsin's Assistant District Attorney of the Year

State of Wisconsin v. Marcus W. Anderson, Monroe County Case 2019CF000353

Anderson beat and tortured a 3 year old child to death. District Attorney Croninger and Assistant District Attorney Skiles led the prosecution of Anderson. In April of 2022 after a 9 day jury trial, Anderson was convicted of 1st Degree Intentional Homicide of the 3 year old. Anderson was sentenced to life in prison without parole.

State of Wisconsin v. Thomas W. Aspseter, Monroe County Case 2021CF000415

Aspseter attacked three elderly individuals with an ax. During the attack Aspseter killed an 87 year old man, and severely wounded a 77 year old man and a 73 year old woman. Assistant District Attorney Skiles led the prosecution of Aspseter. Aspseter was convicted at jury trial of 1st Degree Intentional Homicide, two counts of Attempted 1st Degree Intentional Homicide, and two counts of Aggravated Battery. Aspseter was sentenced to life in prison without parole.

State of Wisconsin v. Brian P. Sanders, Monroe County Case 2022CF00065

Sanders sexually assaulted his teenage step-daughter. Assistant District Attorney Skiles led the prosecution of Sanders. Sanders was convicted at jury trial of 19 counts including, six counts of Incest with Child By Step-Parent, two counts of Child Enticement, six counts of Third Degree Sexual Assault and five counts of Exposing Genitals. The defendant qualifies as a persistent repeater, so he will be sentenced to life in prison at the time of sentencing.

State of Wisconsin v. Anne Nelson-Koch, Monroe County Case 2022CF0000321

In this case the Defendant, who was a teacher, habitually and repeatedly engaged in sex acts with the victim who was one of her students. Assistant District Attorney Skiles led the prosecution of the case. The defendant was convicted of at trial 25 counts, including twelve counts of Second Degree Sexual Assault of a Child, four counts of Child Enticement, one count of Felony Intimidation of a Victim, eight counts of Exposing Genitals.
