Meal Site Financial Data – Discussion: Ms. Weber provided a handout showing expenses compared to contributions for both the congregate meal program and the home delivered meal program. Overall, participant contributions account for approximately 20% of the revenue for the senior nutrition program.

September Malnutrition Month Ride Along – Discussion: Ms. Weber announced September is Malnutrition Awareness Month and offered to this committee as well as County Board Members to complete a ride along with the home delivered meal drivers to see how the program operates and who is served. More information to be shared at a later date.

ADRC Updates: Ms. Weber shared various ADRC updates including information on the Longest Day event, RFP for a nutrition program van, feedback from the Senior Celebration, and a partnership with La Crosse County for a men's group. An ADRC Connect newsletter was also provided.
