RESOLUTION NO.

Resolution Approving Loan to Solid Waste Department for Phase 5 New Cell Construction Project

WHEREAS, the Monroe County Board of Supervisors, under Resolution 03-23-02, approved continuing operations of a Monroe County Solid Waste Landfill; and

WHEREAS, Monroe County strives to provide maximum and efficient service to its residents while minimizing the financial impact of County taxes on tax payers; and

WHEREAS, Monroe County has received notice of award of our \$951,961 ask in congressionally directed spending for the Monroe County Landfill Project; and

WHEREAS, using \$2,492,635 of General Fund Cash Reserves for a Phase 5 Solid Waste New Cell Construction Project reduces the overall tax burden to tax payers by not paying loan or bonding closing costs on borrowed funds; and

WHEREAS, allowing a loan up to the \$2,492,635 that is currently in the Solid Waste Long-Term Closure Escrow Account will allow Solid Waste to payback the General Fund Cash Reserves at time of approval through the new Senate Bill 624 municipal net worth test for our fiscal responsibility commitment; and

WHEREAS, by charging interest to the Solid Waste Department in the amount of 4% APY ensures that County tax payers will recoup interest on the borrowed funds as if the funds were invested with local banking institutions; and

WHEREAS, total interest and principle payments on a \$2,492,635 loan, at 4% APY, with 5 equal annual payments would be \$347,731.53.

NOW, THEREFORE, BE IT RESOLVED, by the Monroe County Board of Supervisors that effective this date they do hereby authorize and direct the County Administrator and Finance Director to transfer funds as needed by the Solid Waste Department up to \$2,492,635 for the construction of the Phase 5 New Cell Construction Project.

BE IT FURTHER RESOLVED, by the Monroe County Board of Supervisors that an interest rate of 4% APY be charged to the Solid Waste Department on outstanding borrowed funds monthly until paid in full.

BE IT FURTHER RESOLVED, by the Monroe County Board of Supervisors that they do authorize the Solid Waste Director, Finance Director, County Treasurer, and County Administrator to complete and submit required documentation to the Wisconsin Department of Natural Resources (WDNR) to meet the new alternate financial responsibility municipal net worth test option per Senate Bill 624.

BE IT FURTHER RESOLVED, by the Monroe County Board of Supervisors that they do hereby authorize the Solid Waste Director and County Treasurer at said time that Monroe County receives confirmation by the WDNR of meeting the municipal net worth test, to submit a request with the WDNR to withdrawal the Irrevocable Escrow for Closure Funds currently with State Bank Financial from the financial responsibility restriction.

BE IT FURTHER RESOLVED, by the Monroe County Board of Supervisors that once the Irrevocable Escrow for Closure stipulations have been removed from the Irrevocable Escrow for Closure Funds, all borrowed funds from the General Fund Investments shall be paid back with accrued interested.

BE IT FURTHER RESOLVED, by the Monroe County Board of Supervisors that they do hereby authorize the Finance Director to increase the 2024 budget for account 63630000 589000 Construction in Progress and 63630000 433030 Congressional Appropriation for \$951,961.

BE IT FURTHER RESOLVED, by the Monroe County Board of Supervisors that they do hereby authorize the Finance Director to increase the 2024 budget for account 63630000 589000 Construction in Progress and 63630000 493000 Solid Waste Fund Balance Applied for the amount of the awarded Phase 5 New Cell Construction Project up to \$2,492,635 in additional approved funding.

55 56 57 **BE IT FURTHER RESOLVED**, by the Monroe County Board of Supervisors that they do hereby authorize the Finance Director to create the needed accounts for appropriate tracking per GAAP of the Solid Waste Department loan from the General Fund Investments.

Fiscal Note: Authorizes and directs the County Administrator and Finance Director to transfer funds as needed by the Solid Waste Department up to \$2,492,635 as a loan at 4% APY for the construction of the Phase 5 New Cell. Additional authorization for the Finance Director to increase the 2024 budget for account 63630000 589000 Construction in Progress and 63630000 433030 Congressional Appropriation for \$951,961. In addition, it authorizes the Finance Director to increase the 2024 budget for account 63630000 589000 Construction in Progress and 63630000 493000 Solid Waste Fund Balance Applied for the amount of the awarded Phase 5 New Cell Construction Project up to \$2,492,635 in additional approved funding. Requires the Solid Waste Department to pay back the 4% loan at time of approval for municipal net worth test. Approval of this resolution will require a 2/3rd's vote of the entire membership of the Monroe County Board of Supervisors for approval.

Statement of purpose: To authorize Solid Waste Department to borrow funds at a rate of 4% APY up to \$2,492,635 for Phase 5 New Cell Construction and apply for alternative fiscal responsibility option municipal net worth test.
