Couleecap Board of Directors

Meeting Strategic Planning Session

Pre-Read

Housing and Energy are two major program areas of Couleecap. They have also been two areas of discussion consistent throughout strategic planning discussions by board and staff. We will consider these areas in more detail at the June Board of Directors meeting. This document will serve as general background for the workshop at the upcoming meeting.

Housing Facts: Coulee Region

- Rental vacancy rates are consistently lower in our area than the national average. According
 to the Census ACS data, the La Crosse area has had rental vacancy rates from 1.37%3.32% lower than the national average since 2016.
- Homeowners do not fair better. Available home inventory to purchase is less than 1%.
 According to the Federal Reserve, it has not been this low since 1978.
- The median age of homes in our area is 1973-1978. 21% of homes in our area were built before 1939. Homes of this age often have lead paint and other issues that need repair.
 Repairs and upgrades can be costly.
- When a housing market is this tight, affordable housing is often rented by people who could afford higher rents. This leaves lower income residents out in the cold...literally increasing homelessness. The shortage of rental homes for extremely low-income residents in WI: 13,484.

Housing Access:

- In a tight housing market, landlords may have multiple applicants for each vacancy.
 Applicants with no credit or poor credit, inconsistent housing references, incidents reported on background checks, or those who cannot afford application fees may be denied or not considered.
- In our area, more housing vouchers (i.e. Section 8 vouchers) are allocated than used. One of the most frequent reasons cited is that landlords will not accept housing vouchers for payment.
- While illegal, housing discrimination exists. Many incidents go unreported. Tenants who
 report may not have their leases renewed or their landlord may find other reasons to evict.
- Many local rental properties have been purchased by large, out-of-town corporations that will not work with housing programs and do not provide proper tenant support.

Housing Affordability:

- 68% of very low-income renters in our area are considered 'severely cost burdened'. This
 means they pay more than 50% of their income on housing.
- 20% of all renter households are considered severely cost burdened.

Energy Facts: Coules Region

- 60% of low-income households in Wisconsin are considered 'severely energy burdened'.
 Severely energy burdened households are paying more than 10% of their household income on energy.
- In the Coulee Region, households in poverty spend an average of 14-20% of their household income on energy – much greater than the threshold for 'severely energy burdened'.
- The highest portion of their energy cost is for the cost of electricity.
- Air conditioning is a large driver of electricity use in the summer. WI is no longer only
 considered a cold-weather state. 2019-2023 were the five hottest years on record for WI in
 almost 130 years.
