### Monroe County Natural Resource and Extension Committee

Regular Monthly Meeting – December 12, 2017 Monroe County Ag Service Center – 820 Industrial Dr., Sparta, WI

The meeting notice was posted in compliance with the open meeting law.

**Call to Order:** Chair VanWychen called the meeting to order at 8:30 a.m.

**Public Comment Period: None** 

**Approve Minutes from the November 40th NR & Extension Meeting:** The Committee reviewed the minutes. *A motion was made to approve the minutes as presented by D. Pierce, seconded by D. Hall. Motion carried, 6-0.* 

Deke Slayton/Bike Museum: None

**Local History Room/Wegner Grotto- Local History Room/Wegner Grotto-** J. Roll reviewed November expenditures and presented report to the committee (attached). J. Roll stated the A-Z display is moving forward. He also reported that the 1950s Christmas display has attracted a record setting amount of visitors, many from out of the county. *Motion was made by D. Pierce to approve the local History Room reports, seconded by M. Halverson. Motion carried* 6-0

1. **Discussion/Action Museum Services Associate Hours:** J. Roll discussed increasing the Local History Room's Museum Services Associates hours from 28 to 30 hours. Roll explained the additional 2 hours would lower the Associate's portion of health insurance deduction from payroll significantly. The additional funds paid to the associate, plus all associated insurance costs, would be paid for by the Local History Room. The additional two hours would cost the County nothing. The Committee was supportive of the increase in hours, as long as the county incurs none of the cost. The Committee questioned who ultimately approves the additional two hours to the position—the Administrator or the full county board.

### **Land Conservation Department:**

- 1. Review November Expenditures: B. Micheel reviewed expenditures, report attached.
- 2. County Conservationist Report: B. Micheel presented department report to the committee (attached). B. Micheel mentioned the news article discussing soil erosion on your property featuring Bryce Richardson as well as DNR forester Megan on Monroe County Invasive Species working group. Micheel also gave an update on the pond drain issue with the PL566 Dam (Luckason). Micheel spoke of the upcoming Monroe County Stewardship Awards Banquet announcing the 2017 winners. The poster and invitation has been developed (handouts). Micheel brought up the 2<sup>nd</sup> annual tree sales (handout). Connie reported 15 orders at this time totaling \$1,600.
- 3. Soil & Water Conservationist Reports: B. Richardson gave an update on completing projects. Richardson mentioned the poster contest judging in January. Richardson will send out the annual nonmetallic mining report and fees to operators in late December. 2018 Nonmetallic fees are due on January 31, 2018. C. Mulder reported completed farm walkovers for the Farmland Preservation Program. Mulder reported FPP Agreement transfer from Tom Schneider to Nicolas Betts in Glendale Township. Also reported three enrollees in FP- David & Diane Brueggen 266 acres, Logan Henthorne 39 acres, and James Kowitz with 570 acres. Mulder mentioned an increase in CREP Program soil rental rates for 2018. (Reports attached).

- 4. **Review/Approve Cost-Share Agreements:** B. Richardson presented a request for cost sharing of a roofed barnyard for landowner Donald Ziese, Grant Recipient Scott Ziese, in the amount of \$14,709.23. *Motion was made by D. Pierce to approve Cost Share Agreement for Grant Recipient Scott Ziese, seconded by J. Schroeder. Motion carried 6-0.*
- 5. Norwalk Rod & Gun Club Lease: B. Micheel discussed the lease termination letter received by the Norwalk Rod & Gun Club. VP Greg Decker and Lucas Bender attended the meeting, representing the newly formed Norwalk Sportsmans Club, would like to take over the lease. Motion by J. Schroeder to release the Norwalk Rod & Gun Club lease and issue a new a club lease for the Norwalk Sportsman Club, second by D. Pierce. Motion carried 6-0.

**NRCS Report:** M. Komiskey reported her 8 months, as Acting State Agronomist, in Madison has ended and stated how she appreciated those who acted in her behalf while she was on detail.

### Agriculture Extension Highlights Update November 15, 2017 to December 12, 2017

The UW Extension Annual Soil and Water Update for Agronomy Professionals was held on November 30th at Sparta. There were 25 participants from around the area in attendance. Topics covered included use of cover crops, using new technology to evaluate field efficiency and trafficking patterns during silage harvest, nutrient management planning and an update on tillage research.

The Ag Agent met with the Monroe County Farm Bureau Board and the Western Wisconsin Beef Producers Cooperative Board over the past month to provide updates on projects and information on future events that they help sponsor and support.

The Wisconsin Beef Information Center webpage that the Ag Agent is the webmaster is on track to receive over 60,000 site visits in 2017. This webpage is the location where our UW Extension beef production resources are located, and where we promote timely educational information.

The corn grain nitrogen trial results yield plateaued out at 180 bushels at 134 lb of nitrogen per acre. The economic optimum nitrogen rate was 126 lb of nitrogen per acre. This rate means that the additional bushels of corn gained with nitrogen applications above 126 lb of nitrogen did not pay for the extra nitrogen under the current corn and nitrogen price scenarios. The results from the trial are now part of the data pool that UW soil scientists use to evaluate and adjust recommendations. See the chart on the following page.

The Ho-Chunk Tribe has hired a manager for their newly formed Agriculture Division. The Ag Agent has begun to work with them to investigate implementing some projects on the Whirling Thunder Farm near Tomah.

The Ag Agents in Buffalo, Chippewa and Monroe County are investigating the feasibility of working with cooperating farmers to conduct some trials of growing industrial hemp. The Ag Agent has been contacted by farmers who are interested in this crop and participating in trials.

The Ag Agent is working with a farmer in the county to look at the feasibility of growing Kernza, a perennial wheatgrass that can be harvested for forage or grain that may be a viable option on some of the more erodible ground.



### Family Living Update November 14 to December 12, 2017

- Stronger Together
  - Last class was November 16<sup>th</sup>. Results Sheet Attached.
- StronaWomen
  - We just started registration for the January session yesterday. We'll have the three locations (Tomah, Sparta, Cashton) and 6 different classes. I will be teaching 1-2 of the classes depending on whether one of my instructors is feeling better by January. We're off to a good start with registration but always looking for more ideas to get the word out in Cashton.
  - I am on the StrongWomen state team. Right now one of the projects I'm working on is the FoodWIse project. This is a way to get physical activity education to low-income audiences across the state. ### **Shooting Sports Committee**

The Agent met with the Shooting Sports committee and established the 2018 Shooting Sports Schedule. The committee felt very ambition this year they are hosting 8 weeks of practice, 2 weeks of fair shoots, and a celebration. Starting January 22 both Archery and Air Rifle will use the full gold building at Recreation Park. The practices will run through March 12. Fair competition shoots will be March 19 & 26. The Group is planning a small wild game feed and celebration night on April 2<sup>nd</sup> to cap off the year.

The other Shooting Sports discussion this past month concerned the necessity of having a shotgun and .22 Rifle program this year. Sparta and Tomah both have a trap league through the school. There are few members in the other districts that attend the program we currently offer. The current decision is to hold off for a year and reevaluate in 2019.

### Reporting

The Agent is working on getting information into the online system to report the great things that have happened in Monroe County 4-H in 2016-17. The Club Charters are uploaded and we are working on getting confirmation letters out to club leaders.

### Warrens Club

The Agent has been talking to a current leader who now works at Warrens Elementary. Both she and I believe there is sufficient interest to start working on a new club in that corner of the county. The plan we developed is to have an open gym at the Warrens Elementary in January, then to have a first official meeting in February. An idea we talked over is to continue the open gyms in Feb & March, having the official club meeting

### **Project and Volunteer Hours**

The Agent has added a requirement to being a member in good standing. All members 3<sup>rd</sup> Grade and above must complete an hours tracking form. The members fill out the form with hours they have spent learning about their projects. The form is signed by a parent or the teacher to document the hours spent learning. The requirement is 10 hours spent learning about animal projects and 6 hours spent learning about non-living projects. There is also a form to track hours spent by adults volunteering. There is not an enforcing mechanism for the forms yet but the agent is working on that.
