MONROE COUNTY ECONOMIC DEVELOPMENT, COMMERCE & TOURISM COMMITTEE MONTHLY MEETING – 3-8-18 – Monroe County Board Room – Sparta

The meeting was posted in accordance with the open meeting law. Meeting was called to order at 9:04am by Chair Sharon Folcey. Roll-call was taken.

County Update – J. Bialecki reported that the Rolling Hills process is continuing but no study has been approved yet. He said that a special Task Force, which includes S. Peterson, Bob Micheel and Allison Elliott, has been formed to perform due diligence on the future options for the County Farm land on Highway B. The group would look at many options over the next weeks & months, and report back to the County Board on possible projects/solutions pertaining to that County land.

Minutes – Motion by N. Van Wychen to approve the minutes of the February 8th, 2018 meeting. 2nd by M.J. Hill. Motion carried.

Financial Report & Invoices – S. Folcey updated the Committee on the current 2018 budget with the condensed version that was easier for the Committee to follow. S. Peterson told the Committee that the annual dues for the Community Venture Network were due and the total amount would be split evenly again with the Cities of Sparta & Tomah. Peterson explained how important this membership is in recruiting companies to our County. He said that with the current business climate in Minnesota with low tax credits, higher proposed minimum wages, Wisconsin is looking very attractive to Minnesota companies to relocate or expand. The 1/3rd investment is \$1,417.00 and is in the 2018 budget. Motion by D. Peterson to pay the 1/3rd membership dues to CVN. 2nd by N. Van Wychen. Motion carried.

Monroe County Economic Development Conference wrap-up – S. Peterson reported that 323 people registered for the Conference. 83 attendees filled out the online surveys. Peterson handed out a summary of the surveys and went through the highlighted areas of the answers. Topics that were addressed:

- Marketplace space issues overcrowded & tight space.
- Dine Around short on food as 2 major businesses were no-shows
- A/V Sound issues poor sound and equipment. Working with Three Bears Resort on those
 issues and P. Harms said they are in the process of upgrading their entire A/V system very soon.
- 53 no shows for attendees who were registered. Much higher that in past years.

- Struggling with comments from attendees that want all the sessions while others want more networking times and a shorter conference.
- Business Spotlights were the most popular with the Top 3 highest rated sessions being AMS Micromedical, FAST Corporation and McPherson Guitars.
- The meet & greets with Governor Walker with some of the prospective businesses looking at Monroe County for location were very productive and progress has already been seen on a few fronts through the contacts with the State agencies.

Peterson said that upgrades for next year's conference have already begun with possibly moving Marketplace back downstairs and having roundtable topics in the Dining Room area. He said that he would periodically report back to the Committee on new ideas and format updates. The Committee commended Peterson on managing another very success E.D. Conference. The dates for next year's Conference are Feb. 27-28, 2019 at Three Bears Resort in Warrens.

Sparta Chamber of Commerce – J. Hendricks reported:

- Attending the Milwaukee Sports Show this weekend
- Sparta & Tomah Chambers are collaborating with the Monroe County Job Initiative on a roundtable meeting on 3/15.
- 3/16 hosting a presentation "All About Pop Up Shops" at 9am at Park Bank Sparta. Nora Roughen-Schmidt, Executive Director Viroqua Chamber Main Street will be presenting.
- Working with Road Runner magazine on a biking/motorcycle trail aerial map

Tomah Chamber of Commerce – T. Thompson reported:

- Currently doing "door-to-door" visits with all the Chamber members. It's going very well and getting great feedback from members. These visits will continue for months until everyone is visited.

SW-ITBEC – N. Van Wychen reported that Chair Jim Ehrsam is having health issues and was not able to attend the meeting. Vice Chair S. Folcey also could not attend so Van Wychen handled the Chair duties for the short meeting. It was decided by the group to start moving the monthly meetings around the SW-ITBEC member areas. May & August – Vernon County; June & September – Jackson County; October – Monroe County – Warrens.

Hidden Valleys - K. Murray reports:

- Attended her 1st HV Board meeting on Feb. 21st as the new Monroe County representative. S. Folcey informed the Committee that Murray has been approved for a 2-year period.
- The County's payment to Hidden Valleys is being processed
- Board voted to add more booth signage, so they can work at more than one trade show at a time
- The back-cover page of this year's magazine is to promote a Photo Contest
- There are 2 sales positions open that need to be filled Green & Richland Counties
- May 16th Annual Meeting Fennimore will be a night meeting
- Each County hosts a monthly Board Meeting July 18th Monroe County Cranberry Discovery Center
- Pres. Joe Fisher is working with UW-Eau Claire on a social media strategy which includes radio spots, web site upgrades and a DVD for sales recruitment for the magazine.
- Cannot attend the March board meeting due to a conflict with her own CDC board meeting.

Local History Room – no report. Jarrod Roll was commended by the Committee for a fine job with the Monroe County Trivia Game at the Monroe County Economic Development Conference, finishing as one of the Top 10 highest rated sessions.

Ft. McCoy – T. Fitzgerald reports (filling in for T. Townsell):

- The Economic Impact of Ft. McCoy on the area was just announced. It was the highest every with a \$1.18 billion impact on the area.
- No Concert this year at Ft. McCoy
- Wrapping up training sessions on the base
- Armed Forces Day May 19th free to the public. Also, the Change of Command will take place that day. Special invitations will be sent out for that event.

Go Monroe County Guides – S. Peterson reported that he had received all the graphics from Evans Printing, so he will be upgrading the www.gomonroecounty.com tourism web site. The graphics will mirror the look of the new 2018 Guide. He also said that there would be a digital version of the guide available on the site as well.

N. Van Wychen questioned how the guides were going to be distributed? According to the contract, Evans Printing is responsible for distribution. She asked that the guides get distributed in the Warrens area soon, so they have them on hand as their tourism season begins. N. Vix, from Evans Printing, in attendance, was asked to pass that information back to Kyle Evans to ensure that the guides would be delivered on time.

S. Peterson asked the Committee for clarity on guide requests that come through the "Contact Us" section of the tourism web site. If it's a single magazine request, he was instructed to split the requests between the Sparta & Tomah Chambers. If it's for a larger request, like a case of guides, he should pass that information on to Evans Printing and they will ship out the guides.
