Nursing Home Building Advisory Committee September 18, 2017

The meeting was called to order in the Rolling Hills Nursing Home Recreation Room at 3:00 p.m. by P Peterson.

- Minutes Approval Motion by R. Sherwood second by N. VanWychen to approve the August 21 & September 1, 2017 minutes. Carried.
- Tour Update P Peterson, N. VanWychen, L. Anderson, and W. Habhegger shared their thoughts to the committee on the tours that were attended on September 30, 2017.
- Results of Geotechnical Study M. Appel, Civil Engineer from AEC, summarized the findings on the two sites (Site 3 & Site 4). In reference to the report it was identified as Option 1 for Site 3 and Option 2 for Site 4.
- Topography Overview and Physical Characteristics of Site Options M. Appel explained the sewer lines in Option 1 would need to be relocated. Option 1 sits lower and because of that the site would require extra fill in order to position the building up more in line to where the current building is. Option 1's construction costs, filling and grading would be more than Option 2. Option 2 site is on the hillside and would not need extra fill, it would require you to cut on one side and fill on the other. The moving of the sewer lines on Option 1 would be much more costly than just running them under County Hwy B to Option 2
- Final Site Selection to Move Forward with Development L. Anderson shared a letter from Bob Micheel, Monroe County Land Conservation Director, outlining his suggestions, concerns, and recommendation to choose Option 1. M. Appel responded to this letter and stated that from an engineering standpoint that Option 2 is the better option to build. Motion made by R. Sherwood, seconded by J. Bialecki, to recommend to the Rolling Hills Committee to build on Option 2. Discussion held. Vote 3-3. Motion failed. P. Peterson stated this will be forwarded to the Rolling Hills Committee without a recommendation. More discussion was held in regards to the vote. Motion made W. Habhegger, seconded R. Sherwood, to reconsider the previous vote. Vote 4-2. Motion carried. Motion made by R. Sherwood, seconded by J. Bialecki, to recommend to the Rolling Hills Committee to build on Option 2. Vote 4-2. Motion carried.
