The meeting was called to order in the Monroe County Board Assembly Room at 3:00 p.m. by Chair Cedric Schnitzler.

- Minutes Approval Motion by Jim Bialecki second by Rod Sherwood to approve the 01/16/18 minutes.
 Carried 7-0.
- Tomah Nursing Home Site with Community Living Solutions Duane Helwig provided four site options for the Tomah Site. There are 7.4 acres that are buildable without touching the knoll on the property. A water and sewer easement divides some of the property, therefore plans include a two story building on sections of the building and an elevator would be needed. Discussion. It was a consensus of the committee to remain with a one level facility, thus removing the water and sewer easement which is estimated to cost around \$150,000.00. Engineers are looking at the possibility of sharing a portion of the retention ponds with the Tomah Hospital. Tom Martin explained that within a month, information would be available on costs. Linda Anderson explained that storage would also be needed for the buses and equipment. She also reminded members that the marketing/feasibility study is needed. Discussion. Motion by Wallace Habhegger second by Rod Sherwood to remain with a single story structure. Carried 7-0.
