The proper establishing, laying out, constructing, and maintaining of the state trunk highway designated a portion of the National System of Interstate and Defense Highways duly laid out and established by its Finding, Determination and Order on May 15, 1959, pursuant to authorization of Section 84.29, Wisconsin Statutes, in Section 13, Township 17 North, Range 2 West, and Section 18, Township 17 North, Range 1 West, in the Towns of Adrian and Tomah, Monroe County, which highway as laid out is more precisely delineated on the map or copy thereof marked "Plat of Right of Way Required, Project I-90-1(18)35," which is a part of the order and map of the Commission issued and approved on March 21, 1967, under the provisions of Section 84.09, Wisconsin Statutes, and filed with the County Clerk and the County Highway Committee of Monroe County, requires that a portion of the public highway located on or along the section line common to Section 13, Township 17 North, Range 2 West, and Section 18, Township 17 North, Range 1 West, the common boundary between the said Towns of Adrian and Tomah, be vacated; and, pursuant to its authority under Section 84.29, Wisconsin Statutes,

ORDERS that

The portion of the existing public highway located on the east line of said Section 13, from a point 1330 feet, more or less, north of the corner common to Sections 13, 18, 24 and 19, thence north 640 feet, more or less, to the north right of way line of Interstate Highway 90, be and is hereby vacated, said vacation to be effective on the date construction of said state trunk highway begins within the portion of road to be vacated.

A copy of this Finding, Determination and Order shall be mailed to the County Clerk and the County Highway Commissioner of Monroe County, to the Town Clerks of the Towns of Adrian and Tomah, and to each owner of lands abutting the vacated local road.
